

## Care of these Animals

#### **Pigs/Lambs/Goats - 4 months**

- Require twice daily feedings (Morning and Evening)
- Daily care of animal pen Keeping bedding clean of feces and wet spots
- Regular exercise and show training

#### Chickens/Rabbits - 5 - 7 weeks

- Keeping bedding clean of feces and wet spots
- Constant food and water
- Chickens Constant monitoring of temperature
- Rabbits monitoring weight and feed intake

#### **Auction Rules**

### PAGE 50

This is a TERMINAL SHOW

All market animals shown at the Show will be processed for food production. NO EXCEPTIONS. If the market animal was shown at the Spring Branch FFA Show, it must be processed.

- Only MARKET animals will be sold at auction.
- All entries get to cross the auction block with the exception of Chickens and Rabbits - entry limits
  - Chickens Only the top 25 pens
  - Rabbits Only the top 12 pens
- ALL Exhibitors must fully participate in all mandatory aspects of the Show & Sale Week.
  - Work Day
  - Setup the night before/morning of the auction
  - Stay for the full duration of the Sale
  - Clean up on Sunday

## Rule Changes

Each year we hold a Rules Committee Meeting where we review the rules, new rules and/or changes are proposed and discussed and voted on by the membership. This year it will be on February 27. See important dates.

Following our Show & Sale we will need help reviewing and updating our rules. Please consider joining this committee.

### Payments to Exhibitors - Page 20

- And finally... when students have completed all of their Show & Sale Requirements they will receive a check for their earnings.
- #12 is an explanation of how the exhibitor checks are calculated.
- Sale Price (10% Sale Price) + (Add Ons 8% service fee) (Ad Sale Deduction Opt) (Fines) = Exhibitors Check
- They must have completed all of the criteria under #13.
- They must satisfy all points requirements yellow, blue, greenChecks will be distributed at the banquet in May.
